"Best practice in the preparation of patients for bariatric surgery"



The rise of obesity in the UK population has been well documented. The Foresight Tacking Obesities project (Jan 2010, www.foresight.gov.uk) has been one of the many reports to present alarming figures for the likely prevalence of obesity in future generations. Whilst the role of prevention in tackling obesity has received attention in the Change4Life campaign, the role of Bariatric Surgery as a treatment cannot be ignored. The field of Bariatric Surgery in the UK is young but growing fast and likely to continue doing so. At present there is little consensus amongst surgical centres on many of the issues surrounding the management of an undeniably complex and challenging patient group.
