To preserve anonymity, only national reports of those countries with 6 or more participating units are provided on the nutritionDay website for download.

30-Days-Outcome

Please complete the 30-Days-Outcome evaluation questionnaire for **nDay in hospitals** on the **9th of December, 2017**. You can find the questionnaire "30-Day-Outcome" in your preferred language [here](#). Please use the patient's medical record for your outcome data collection. You do not need to contact the patient for this information.

The outcome evaluation for ICU-patients should take place 60 days after nutritionDay (8th of January, 2018). In nursing homes, the outcome should be evaluated 180 days after nutritionDay (8th of May, 2018)

As usual, you can do your data entry via our homepage www.nutritionday.org. Click „my nutritionDay | login“ → “data entry | upload” and choose your category.

Data entry

As usual, data entry is possible via our website www.nutritionday.org. Click → “my nDay | login” → “data entry | upload” and choose your category (hospital, ICU or nursing home).

Log in with your centre and unit code (as indicated below) and complete „sheet 2 & outcome data” for each patient.

e.g. Centre code: 1234, Unit code: 5678

Data Entry Code: 1234nd5678 (exchange “nd” with “icu” or “nh” for your category)

Unit Code: 5678

Due to a content management system update in September/October, some login problems occurred for participants who registered during this time period. The problem should be solved, however please let us know if you are still experiencing any problems with the log-in to the data entry.

Get your certificate!

nutritionDay participants receive a certificate! To receive the nD certificate, three quality criteria have to be met:

1. Minimum of 8 patients/residents have to be included in the audit per unit (this is also the minimum number required to receive a unit report).
2. Minimum of 60% of all patients/residents present on nD have to be included in the nD audit.
3. Minimum of 80% of patients/residents (which have participated in nutritionDay) have to be included in the outcome evaluation 30 days (hospitals) or 180 days (nursing homes) after nD.
